**Juried Criteria for Art by the RIVER**

- **ALL WORK MUST BE ORIGINAL ART** (or prints of same) **or CRAFT DESIGNED, CREATED AND MADE BY THE EXHIBITOR.**
- **Mass produced and/or items purchased for resale are not accepted.** Imported/maufactured goods will not be considered.
- **New exhibitors** must send/email a resume, 4-5 photographs of the booth setup, work you plan to sell and a product list with price range. Include information on how you will promote the event through social media. These submissions will not be returned but will be kept in our files to streamline the process in subsequent years. **Previous exhibitors must submit new items for jurying. EXHIBITORS CAN DISPLAY/ SELL ONLY ITEMS THAT WERE APPROVED BY THE JURY.**
- **Quality and originality of work will be deciding factors.**
- If for any reason it is found your work is not original, you will be ask to remove it. Your application fee will not be refunded.

I have read and understand the juried criteria for Art by the River 2020 and ensure only items that meet this criteria will be exhibited and sold by me. Decisions of the selection committee are final.

**Application Deadline: April 30**

- Applications are processed and juried by date received on an ongoing basis. If you want to assure yourself a site for 2020, apply early to avoid disappointment & late fee charges.
- **Payment must be received with your application – it will only be cashed after acceptance.** Applicants are notified of their status by email and a receipt sent if accepted. Those not accepted will have their cheques shredded.
- In July, an Exhibitor package outlining all the show details will be emailed/mailed to each exhibitor.
- **included in your site fee are 2 Exhibitor Passes with names and site number . These will be available at your assigned gate at Set-up Times. Please advise if a third is needed. More than 3 are subject to admission.**

**ART by the RIVER is an outdoor rain or shine show on the grounds of Fort Malden NHSC.**  
Exhibitors must not disassemble or remove any part of their display during show hours, except in an emergency situation with the approval of the ART by the RIVER Committee.
