Terms and Conditions:

- Exhibit will be open to the public for the dates and hours as outlined. Exhibitors must not disassemble or remove any part of their display until November 5, 2023 at 4:00pm.
- Original work only. ALL FIBRE MEDIUMS, eg. needlework, rug hooking, quilting, felting, etc. Each artist allowed one piece, with a possibility of a second, if space allows. All work submitted will be subject to the discretion of the Gibson Gallery exhibit committee. Quality and originality will be deciding factors.
- All wall pieces must be wired and ready for hanging. Sculptures must be able to sit sturdy on pedestal or floor.
- Maximum size (28"x40" or 1120 sq. inches) framed or gallery wrapped.
- Name and contact info to be placed on the back of the piece.
- Register with \$12 non-refundable entry fee
- Digital images to be sent to office@gibsonartgallery.com for review and acceptance no later than September 10, 2023. Artists will be notified of acceptance no later than September 13, 2023.
- Artwork to be delivered between 12-5 pm on September 28-October 1, 2023 and picked up Sunday, November 5, 2023 after 4:00pm.
- Please note that your works may be photographed for promotional purposes by the Gibson Gallery or media attending the exhibit.
- Sales are subject to 20% commission and payment of credit card transaction fees incurred
