### Terms and Conditions:

- Exhibit will be open to the public for the dates and hours as outlined. Exhibitors must not disassemble or remove any part of their display until July 28, 2019 at 4:30pm.
- Original, representational work only. All mediums. Each artist allowed one piece, with a possibility of a second, if space allows. All art submitted will be subject to the discretion of the Gibson Gallery exhibit committee. Quality, originality of work and consideration of the theme will be deciding factors.
- All wall pieces must be wired and ready for hanging. Sculptures must be able to sit sturdy on pedestal or floor
- Wrap around canvas need not be framed provided it is painted on all sides and no staples.
- Maximum size (28"x40" or 1120 sq.inches) framed or gallery wrapped.
- Name and contact info to be placed on the back of the piece.
- Pre-register by April 30, 2019 with \$10 non-refundable entry fee to cover cost of the exhibit, including prizes
