### Juried Criteria for Art by the RIVER POP-Ups

- ALL **WORK MUST BE ORIGINAL ART** (or prints of same) **or CRAFT DESIGNED, CREATED AND MADE BY THE EXHIBITOR.**
- **Mass produced and/or items purchased for resale are not accepted.** Imported/maufactured goods will not be considered.
- If for any reason it is found your work is not original, you will be asked to remove it. Your application fee will not be refunded.

- Applications are processed and juried by date received on an ongoing basis.
- Consideration is given for dates requested, within attention given to similar type of exhibitors received.
- **Payment must be received with your application – cheques will only be cashed after acceptance.** Applicants are notified of their status by email and a receipt sent if accepted. Those not accepted will have their cheques shredded.

**ART by the RIVER Pop-ups are an outdoor rain or shine show.**

Exhibitors must not disassemble or remove any part of their display during show hours, except in an emergency situation with the approval of the ART by the RIVER Pop-up Committee.
